Fire-extinguishing work is done from the windward and the suitable fire-extinguishing method according to the surrounding situation is used. Uninvolved persons should evacuate to a safe place. In case of fire in the surroundings: Keep containers cool by spraying with water. Eliminate all ignition sources if safe to do so. When extinguishing fire, be sure to wear personal protective equipment

### 6.3 Methods and materials for containment and cleaning up

Absorb spilled material in dry sand or inert absorbent before recovering it into an airtight container. In case of large amount of spillage, contain a spill by bunding. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations. Remove all sources of ignition. Fire-extinguishing devices should be prepared in case of a fire. Use spark-proof tools and explosion-proof equipment.

### 7.1 Precautions for safe handling

Handling is performed in a well ventilated place. Wear suitable protective equipment. Be careful not to cause leakage, overflow, or dispersion. Steam should not be generated unnecessarily. Keep away from heat/sparks/open flame/hot surfaces. -No smoking. Take measures to prevent the build up of electrostatic charge. Use explosion-proof equipment. Avoid shock and friction. Wash hands and face before breaks and immediately after handling the product. Use a closed system if possible. Use a ventilation, local exhaust if vapour or aerosol will be generated. Avoid contact with skin, eyes and clothing.

Keep container tightly closed. Store in a cool, dark and well-ventilated place. Be sure not to give the container unexpected impacts, such as falling down or falling off. Store away from incompatible materials such as oxidizing agents.
